
Read all of Luke Chapter 16. It is all about **Wise Stewardship** of Other Peoples Wealth!

Now we will Contrast modern irresponsibility with Accountable Stewardship of the Wealth of Others that JESUS Christ Spoke This Parable About: Luke 16:1. And He said also unto His disciples, There was a certain rich man, which had a Steward; and the same was accused unto him that he had wasted his goods. And He called him, and said unto him, How is it that I hear this of thee? give an account of

thy Stewardship; for thou mayest be no longer Steward. Then the Steward said within himself, What shall I do? for my Lord taketh away from me The Stewardship: I cannot * dig; and to beg I am ashamed.
